The Kierson Riding Academy teaches lessons by appointment only 7 days a week on farm owned school horses. We also offer participation in local fun shows and tournaments in addition to our Academy and Show Teams. Kierson Farm's instructors are dedicated to creating a safe atmosphere of learning and responsibility for all students, ensuring a positive and productive introduction to horses.

Kierson Farm owns many seasoned lesson horses to babysit the smallest of rider and to challenge the most accomplished equestrians!

Memberships include once a week lessons per person.

Payment is due at time of registration and renews automatically each month unless canceled.

All lessons are by appointment and times depend on availability. Please call or email to register or schedule lessons.

Private Membership: \$325

Lessons are 30 minutes while riders are one on one with the instructor. Private lessons are perfect for the rider who is looking for a more intense and serious approach to riding.

Tiny Tot Membership: \$225

Private Lessons for riders 3-6 years old. Lessons include 20 minutes of riding and 10 minutes of grooming and horse time.

Mommy and Me Membership: \$325

Great private lesson for parent and tiny tot rider to spend time together doing a fun activity. 20 minutes of riding.

Private Type Lessons are offered Weekdays 1-5 (Tuesday until 7) and Sunday 9-12

Group Membership: \$275

Group lessons are offered for all ages. Lessons are 1 hour in length, with 45 minutes of riding time and 15 minutes grooming and horse care. Group lessons are offered for all level riders. Group lessons are a great way to gain experience or increase you endurance and fitness level.

Academy Membership: \$575

The Academy Package designed for the rider who is ready to begin competing. The package consists of 1 group and 1 private a week.

Lunge Lessons/Yoga on Horseback: \$35 each

Group Type Lessons are offered Mondays at 5pm and 6pm, Wednesdays at 6, Friday at 5 and 6 and Sunday 12pm.
